The Impact Fund for Children operates and administers the Bridge Fund on behalf of the UNICEF USA. The Bridge Fund provides financial resources to secure better pricing, faster delivery and a consistent flow of essential goods for children in the developing world by distributing critical, flexible capital to overcome traditional funding obstacles when purchasing urgently needed supplies that save children's lives. In FY20 the Bridge Fund accelerated \$60.4 million, targeting 256 million children and individuals. Impact highlights include: * \$17 million of COVID-19 supplies including PPE, diagnostic kits, and medical supplies accelerated to the field * 173 million polio vaccines prefinanced in continued fight to eradicate polio * Stockouts of essential vaccines, medicines and medical supplies prevented in Central African Republic and the Democratic Republic of the Congo * \$1 million accelerated after Hurricane Dorian shortened UNICEF response time, including delivery of safe water to more than 9,500 children and families
