Introducing UNICEF USA's Child-Centered Governance Research-to-Policy Series, which highlights five strategies to help governments center children's best interests and perspectives in decision-making. The series translates research and promising practices into actionable approaches for communities to implement.

CHILD-CENTERED GOVERNANCE BRIEF SERIES AT A GLANCE

Child-centered governance is a transformative, evidence-informed approach to public decision-making on policies, priorities and resource allocations that places the well-being and voices of children at its center. It emphasizes inclusive and accountable governance, in which children and young people can meaningfully participate in decisions that affect them, public budgets reflect their needs and priorities, and independent advocates elevate their perspectives.

This brief series draws on extensive review of existing research, international guidance, government reports and promising practices in the U.S. and globally, as well as key informant interviews with practitioners working at the national, state and local levels. Together, these insights point to common strategies for embedding children's voices and well-being into government systems.

This effort to bridge research, policy and practice on child-centered governance was born from UNICEF USA's Child Friendly Cities Initiative (CFCI), which unites local stakeholders to create safer, equitable, inclusive and child-centered communities. Launched in the U.S. in 2020, CFCI partners with communities like Minneapolis, MN; Decatur, GA; and Boulder, CO, to demonstrate the potential of child-centered approaches while revealing the need for a broader set of tools that other governments can adopt. Their experiences – together with evidence from global partners – highlight that there is no one-size-fits-all model. However, there are commonalities in what makes child-centered governance strategies effective and efficient to guide decision-making.

Drawing from this evidence and experience, the series highlights five interconnected strategies UNICEF USA promotes to put children at the center of local governance:

- **Child Impact Statements** to assess how proposed policies affect children
 - **Youth Councils** to provide young people with a structured role in decision-making
 - **Children's Cabinets** to coordinate leadership across agencies and sectors
 - **Child-Friendly Budgeting** to track and prioritize spending on children's needs
 - **Youth Ombuds Offices** to serve as independent advocates and protectors of children's best interests

Many governments lack a clear roadmap and practical guidance for prioritizing the voices and needs of children in policymaking. Child-centered governance fills this gap by helping governments take more intentional and coordinated action for and with children.

CHILD-CENTERED GOVERNANCE IMPACTS AND OUTCOMES

Emerging evidence and experience suggest that these strategies help governments design more equitable, effective and responsive systems. While causal links to improved child well-being are still being established, the strategies show clear promise.

Equitable and Responsive Policies: Including children’s perspectives and using tools like Child Impact Statements leads to policies that better meet the needs of all children and reduces unintended harms.^{1,2,3,4,5}

Effective and Targeted Resource Allocation: Child-friendly budgeting and coordinated governance ensure resources are strategically directed, services are tailored to community needs and new funding opportunities are mobilized.^{6,7,8,9,10}

Transparency and Accountability: Participatory mechanisms, oversight bodies and public reporting improve governance, track progress toward shared goals and strengthen trust in decision-making.^{3,11,12,13,14}

Youth Engagement and Leadership: Participation in governance fosters civic identity, empowerment, leadership skills and social-emotional development, creating pathways for lifelong civic involvement.^{15,16,17,18,19}

Community Resilience and Long-Term Child Well-Being: Cross-sector coordination and child-centered governance enhance crisis responsiveness, strengthen communities and contribute to lasting improvements in children’s health, education and safety.^{4,5,6,20,21,22,23,24}

KEY CONSIDERATIONS FOR IMPLEMENTATION AND GETTING STARTED

Child-centered governance is most effective when approached as a coordinated, system-wide effort. While each strategy can be pursued individually, they are mutually reinforcing:

- **Youth Councils** surface priorities that inform **Child-Friendly Budgeting** or guide **Children’s Cabinets**.
- **Child Impact Statements** provide evidence to strengthen decisions made by **Children’s Cabinets** or **Youth Ombuds Offices**.
- **Youth Ombuds Offices** monitor whether commitments made through **Child-Friendly Budgeting** or **Children’s Cabinets** are implemented, reinforcing accountability.
- **Children’s Cabinets** coordinate across agencies and strategies, ensuring that youth priorities identified by **Youth Councils** and evidence from **Child Impact Statements** shape policies and budgets.

Communities can start small – engaging youth in policy discussions, reviewing budgets through a child-focused lens, or forming cross-agency working groups – and gradually build toward more formal structures.

The accompanying briefs in this series offer further guidance for local leaders and practitioners, with evidence, case studies, and practical steps to support implementation. Together, they can help governments deepen understanding of how these strategies contribute to more coordinated, child-centered governance; learn from real-world examples; and identify actionable entry points to strengthen local systems.
